# DISCUSSION ABOUT THE AMENDMENT TO CHAMBER BY LAWS

The first and second amendments to the bylaws were reviewed. Defined that the purpose of in-camera meetings would be

- to provide an opportunity for the board to discuss particularly sensitive matters within the jurisdiction of the board (such as litigation, labour relations, or management performance)
- to provide an opportunity for the board to discuss sensitive internal board governance matters
- to provide an opportunity for the board to review the performance and compensation of the staff, in the absence of resource officers or others who are not members of the board
- in the case of internal and external auditors, to safeguard the independence of those officers by providing direct access to the board without members of the administration in attendance

If any business is to be conducted or motions carried at an in camera session, a record the decision(s) for the minutes will be made, and the item should be included in a confidential addendum to the minutes and brought to the next meeting of the board for approval.
